WARRANTY DEED - JOINT TENANCY

North Half (N ½) of Northeast Quarter (NE ¼) of Southwest Quarter (SW ¼), except coal and minerals; North Half (N ½) of Northwest Quarter (NW ¼) of Southeast Quarter (SE ¼), except coal and minerals; and North Half (N ½) of Northeast Quarter (NE ¼) of Southeast Quarter (SE ¼), all in Section Thirty-three (33), Township Eighty-five (85) North, Range Twenty-seven (27) West of the 5th PM, Boone County, Iowa, except Parcel "A" in Northeast Quarter (NE ¼) of Southwest Quarter (SW ¼) and in the Northwest Quarter (NW ¼) of Southeast Quarter (SE ¼) of said Section Thirty-three (33), as shown on "Plat of Survey" recorded in Plat Book 34, Page 108, in the office of the Recorder of Boone County, Iowa.
